RCM Report

Good morning

I attended the hybrid On-Month Regional meeting on October 9, 2021. Nine (9) areas were in attendance.

- 1) Free State: Wayne-
- a) The Pre-Registration target of 600 has been reached (*Correction Last month we wrongly reported the number to be 500*). This number also includes 192 packages for newcomers under 3 years. From now on, those we desire to attend the convention but have missed out on this opportunity will have to do so on-site. Total capacity will be 1200
- b) The Banquet has been completely sold. The others meals still had some openings: Saturday morning Breakfast; Saturday Relationship Lunch, and Sunday morning Breakfast Jazz.
- c) Catering goals have been exceeded. Contract with BWI is at \$10,000. However, the Presold amount is over \$22,000.

2) Service Center: Franck

- a) Literature sales is at \$23,3850.
- b) The Service Center is out of hard cover Basic Texts due to the shortage at the World. Do not know when it will be back in stock. However, the RD mentioned they will be more come October 15. It's also possible we end up with other literature shortages.
- 3) Circle of Sisters Representative provided an update on the preparations for next convention in March 23. Various activities are scheduled such as a trip to Atlanta March 11-13 2022, and a family walkathon October 30 at Montebello lake in Baltimore from 9am-12pm.

4) Chair- Kellie:

- a) The chair is asking for an urgent need of a co-chair.
- b) From now, the sub-committees can meet at the Service Center at 10:00. Regional Chairs are also welcome. However, PR and phone line sub-committees would like to keep meeting on-line. Baltimore H&I would also elect to stay on-line.
- c) The modality of meetings on-line vs hybrid was also discussed. The sub-committees will meet next month (off-month meeting) to discuss modalities going forward and to figure out respective schedule on ZOOM.
- 5) **Policy Facilitator- Joe:** requested for incoming Motions to be sent beforehand to policy via e-mail in order to proofread language and check on status.

6) RD- Chris:

- a) Recommends to go to NAWS website for updates.
- b) The RD also provided some good news: members donation as a whole have increase at the World. It is at an all time high and has reached the goal of being at 25% of operating expenses.
- c) NAWS as able to reincorporate staff furloughed last year.
- d) Sale of Literature at the World is down (possibly due to on-line meetings precluding physical presence). Compound to that, the costs of production and shipping fees have increased.
- e) The US Court case is still active further draining our resources. The order party did lodge an appeal since they lost the case. It is expected to be heard sometimes on 2022.
- f) Other topics and items currently under work are:
 - a. Final draft of Spiritual Principles a Day book is almost done.
 - b. Virtual meetings best Practices recommendations have been posted at the world www.na.org/toollbook. The draft version will be posted until November 30. Members are encouraged to visit and comment until then.
- g) There was a Consensus decision to have the World Convention on 2023 at the earliest.
- h) Term limits: ask for an extension for the 6 Members at the World which terms expire on 2022.

7) RDA- John:

- a) Revisions to celebrate the 60th Anniversary of the Little White Book is currently being done. Input is welcome at the World and the deadline to do so is fast approaching.
- b) A combined CAR/CAT report will be issued on November 24.

- c) Working at the World on Guidelines for predatory, disruptive and violent behaviors
- d) Next Autonomy Zonal Forum meeting will be hosted by Free State on January 29-30, 2022. Working on possible locations. The Bay area seems one of the more likely target. Breakfast and lunch will also be served.

8) Literature Sub-Committee Reports:

- a) Need more attendance from areas at Region Zoom meeting.
- b) Spiritual Principle A Day Book- Comments and suggestions submission are over. Moving on to next phase.

9) PR Sub-Committee- Sam

- a) The sub-committee will meet Monday December 6 at 6:00 PM on Zoom
- b) The Tuerk Conference was held and it was a success.
- c) The Billboard is up at the Delmarva area, outside of Lewis. It will be up from September 13 until October 13. Next location will be the North West area. The chair will go at the area service to iron the details.

10) Phone Line Sub-Committee- Michael:

- a) A total of 5 persons met today.
- b) The new YAP system is working to satisfaction.
- c) The sub-committee is currently revamping the report system. It is expected to be completed in one month time.
- d) Current open shifts: Tuesday 1-5, 5-8; Wednesday 5-8, 8--11; Friday and Saturday overnight
- e) A workshop is being planned for December
- f) There were 3% of missed call and 12% of rejected calls which occur when a volunteer answers, and hangs up the phone.
- g) The meeting search function is programmed to list a total of five meetings according to zip code.

11) Treasurer: April

a) \$1340.77 are available to donate.

12) Old Business:

- a) April provided an update on the Regional Insurance Ad Hoc committee. They are working on independent quotes for each area. So far it is forecast the cost will be \$2000 per area yearly for a total cost of \$20,000 a year for the Region. The committee will continue to gather information.
- b) The proposal to adopt Consensus Based Decision to conduct our deliberations at the Region was again brought up. Currently this system is done at the World. They

would like to try for 3-6 months at the Region. How it works, anyone present at the meeting can make a motion but only the RCM will vote. A straw poll will be presented and if it reaches 83%, the decisions will be obtained.

c) NE Freedom made a Motion to have the RD and RDA conduct Workshop on Consensus based meeting.

13) New Business

Northeast Freedom asked to redress two motions:

a) First Motion reads:

"The Baltimore Area of Narcotics Anonymous moves that the Free State Region of Narcotics Anonymous to donate all funds in excess of Prudent Reserve, Budgeted items, and earmarks, to NAWS".

North East argue the maker of the motion should not be in the body of the motion itself. It is already stated in the "Maker" section. Also, stating Narcotics Anonymous in the motion makes it read as an outside entity. We are NA and it doesn't need to be stated in the motion.

Proposed new wording to read:

"The Freestate Region to donate all funds in excess of Prudent Reserve, Budgeted Items and Earmarks, to NAWS".

b) Second Motion reads:

"To reinstate the billboard project" that was previously approved.

The issue with this motion is that it is to ambiguous. Years from now no one will know what we are talking about. This motion should reference the motion it pertains to as well as give the date when the motion was passed.

I. NAME: Baltimore Area Hospital and Institutions Committee of Narcotics Anonymous

Il <u>Purpose:</u> This service committee was formed by and is directly responsible to the BALTIMORE AREA SERVICE COMMITTEE OF NARCOTICS ANONYMOUS (BASC). The purpose of the Hospital and Institutions (H&I) Subcommittee is to carry the N.A. message of recovery to the addicts who do not have full access to regular Narcotics Anonymous meetings. H&I meetings/presentations except for those in longer term facilities, are intended to simply introduce those attending to some of the basics of the N.A. Program. An H&I meeting/presentation is always held under the auspices of an H&I subcommittee. Any meeting not linked into the service structure in this way is not an H&I meeting. The H&I subcommittee shall work in conjunction with Public Relations subcommittee of the Baltimore Area Service Committee of N.A. all of the BASC H&I activities will be carried out in accordance with BASC Policies, The Twelve Traditions, The Twelve Concepts, and the Narcotics Anonymous World Service (NAWS) handbooks.

III Functions and Responsibilities:

- Is directly responsible to the BASC and the Groups
- To hold regularly scheduled monthly business meeting
- To communicate and disburse all information to and from the H&I members
- To provide representation and participation in the BASC and Free State Regional Area H & L of N.A.
- To coordinate, Recruit and develop H&I learning activities for N.A. members
- To elect/appoint members to fulfill the needs of the subcommittee
- IV. <u>BUSINESS MEETINGS</u>: The BASC H&I subcommittee will meet regularly each month. The meeting time will be publicized to the Groups, Area and Region encouraging all interested members to attend
- V. **<u>FUNDING</u>**: The H&I subcommittee will submit and maintain a yearly budget, funded by and in accordance with BASC Policies
- VI. <u>AMENDING STANDARDS:</u> The BASC H&I Subcommittee may amend these standards by a group conscience decision, subject to approval by the BASC Body
- VII. <u>MEMBERSHIPS</u>: Members of this H&I subcommittee will be defined per one or more of the following: Chairperson, Vice-chair, Secretary, Alternate Secretary, Literature Coordinator, Alternate Literature Coordinator, Coordinator, Alternate Coordinator, Panel Leader and Panel member
 - Any member of NA has the right to address any subcommittee with H&I related business as well
 as attend our regular H&I subcommittee monthly meeting (reoccurring every 4th Saturday at
 12:30 p.m.)
 - VIII: <u>Voting Memberships:</u> Voting membership of this H&I subcommittee shall consist of all the above:

All voting members will have equal rights of input and vote on decisions made by this subcommittee, except for the chairperson, who carries a vote only in the case of a tied vote,

A voting H&I committee member must have attended at least one (1) of the previous two (2)
 BASC H&I subcommittee meetings

IX: Trusted Servants Qualifications/Elections/Removal

- 1. The Chairperson will be elected in December of each year by BASC, and is accountable and subject to BASC Policies including attendance & fiscal responsibilities
- 2. The H & I subcommittee will elect the Vice Chair, Secretary, in January and all trusted servant's positions will be open for nominations each year,
- 3. No trusted servant will be eligible to serve more than two (2) terms consecutively in the same position
- **4.** All trusted servants must attend the monthly BASC H&I subcommittee meetings. More than two consecutive, unexcused absences constitute resignation of H&I commitment. Whether an absence is excused or not will be decided by the group conscience of the subcommittee.

X: <u>Chairperson:</u> Elected in accordance with and held accountable to BASC procedures for a one-year service term.

A. Qualifications:

- 1. Required minimum of two (2) years continuous abstinence from all drugs
- Suggested to have a NA homegroup, a NA sponsor, and Area or Regional service experience
- 3. Suggested to have a working knowledge of the 12 Steps, 12 Traditions and 12 Concepts of NA
- 4. Suggested to have a working knowledge of BASC Guidelines and Policies
- 5. Suggested to organize and serve the H&I subcommittee
- 6. Suggested to have a willingness to lead, organize and serve as well as give the time and resources necessary to conduct the business of the H&I subcommittee

B. **DUTIES**:

A. Qualifications:

- 1. Required minimum of two (2) years continuous abstinence from all drugs
- 2. Suggested to have a NA homegroup, a NA sponsor, and Area or Regional service experience
- 3. Suggested to have a working knowledge of the 12 Steps, 12 Traditions and 12 Concepts of NA
- 4. Suggested to have a working knowledge of BASC Guidelines and Policies
- 5. In the absence of the Chairperson, shall perform all of the duties and responsibilities of the Chairperson

B. Duties:

- c. Suggested to have basic secretarial and organizational skills
- d. Suggested to have a NA sponsor and a NA homegroup
- e. Suggested minimum one (1) year continuous abstinence

Duties:

- a. Keeps and maintain accurate H & I subcommittee meeting notes & minutes and distributes to committee members prior to subcommittee meeting
- b. Present prior meeting minutes during subcommittee meeting

- c. Keeps and updates volunteer list of members who would like to go to a H&I meeting virtual or in-person
- d. Expected to attend all H & I subcommittee meetings
- e Maintains an on-going file of all correspondence and minutes
- f. May have other assigned responsibilities of the H&I subcommittee

XIII. Literature Coordinator--1 year clean-time required Elected by majority vote of the subcommittee for term of (1) year

Qualifications:

- a. Suggested minimum one (1) year continuous abstinence
- b. It is the responsibility of the literature coordinator to distribute NA literature conference approved literature and any other items the subcommittee uses to carry the NA message
 - c. Have a working knowledge of the 12 Steps, 12 Traditions, 12Concepts, a NA homegroup and NA sponsor
 - b. Ability to organize
 - c. Keep record keeping skills

C. Duties:

- a. Order and distribute NA conference approved literature
- b. Maintain a stockpile of NA approved literature (
- c. Deliver literature to various facilities such as Reaching Out, meeting schedules, information pamphlets (IP) etc.

XIV. Alternate Literature Coordinator 6 months clean-time

Elect by majority vote of the subcommittee for a term of (1) year

Qualifications:

- a. NA Sponsor, NA homegroup
- b. Willingness to seek knowledge of 12 Steps, 12 Traditions & 12 Concepts

Duties:

a. Work with Literature Coordinator to fulfill the duties/responsibilities

b. Perform all duties in absence of Literature Coordinator

XV. Panel Coordinator 1 year clean-time required

Elected by majority vote of the subcommittee for a term of (1) year

Qualifications

- a. It is the panel coordinator's responsibility to see that the meeting/presentations are conducted in accordance with the policies of the H&I subcommittee and the rules of the facility. This person acts as the liaison between the H&I subcommittee and a given facility. A panel coordinator maybe responsible for only one facility, several, or all the facilities that the subcommittee is working with. This will depend on the needs and the conscience of the H&I subcommittee. In some areas the responsibilities of the panel coordinator fall under the job description of one, of the other officers, such as a chairperson or vice chairperson. This would work in a smaller area but as the number of facilities you're dealing with grows, you may want to elect one or more panel coordinators to handle the additional responsibilities
 - b. One (1) year clean time required
- Suggested to have knowledge of the 12 Steps, 12 Traditions and 12 Concepts of NA
- c. NA sponsor and NA Homegroup
- d. Must attend all H&I Subcommittee meetings to give status report of the facility
- e. Must communicate with Panel leaders from the facility
- f. Fill in on the 5th week of the month to fulfill the responsibility of secretary of the meeting

XVI Panel Leader 90 days clean time required

Elected by majority vote of this subcommittee for a term of one (1) year

- a. The panel leader selects members of the NA fellowship to be panel members usually from a panel member list. The panel leader is responsible to ensure that the meeting starts and ends on time
- b. Any problems should be reported to the panel coordinator and then included in the regular report to the H&I subcommittee
- c. Review the NA Do's and Don't(s) of the subcommittee and H&I prologue

XVII Panel Member 6 months clean time required

Elected by majority vote by the H&I subcommittee for a term of one (1) year

a. Six (6) months clean time and a willing to share their experience, strength, and hope

b This is an essential element of H&I work-the members who goes to share his, her their experience, strength and hope at the H&I meeting Without these people, our H&I work would be completely impersonal at best.

- C Shall serve for one meeting at a time
 - d. Areas should develop some basic requirements for members who are to carry the message in H&I A good understanding of the fellowship and the policies relevant to this H&I meeting is essential. A packet may be developed that will outline what is essential. A packet may be developed that will outline what is expected of panel members.
- *Orientation of inexperienced members is a good idea (see page 97 -100 in the H & I Handbook and the H&I Basic's handbook)

we Shall take an active role in a meeting as a speaker or in whatever other acceptable capacity as may be requested by the panel leader

- f. Shall always keep in mind that panel member may be seen as a representative of NA and should contact NA and should contact himself or herself responsibly
- g. May resign as a panel member by giving notice to the panel leader
