



RCM Alternate Report

Greetings to all

I attended the MARLCNA meeting on February 8-10 at Lancaster, PA. Various workshops were held and there are a few projects in development:

Literature

The world service is currently working on a couple of IPs and book:

- 1) The NA Groups & Medication IP. This IP which came from the result of the fall 2016 CAR survey, offers some guidance to groups on how to deal with meetings participants who are currently on medication. A distinction is made between those who are currently taking medication as a result of illness, injury, or others health related conditions (Medication Assisted Treatment) and, those who are on drug replacement therapy. For the later, the third tradition reminds us that we are a fellowship free of any minds or moods altering chemicals. Regardless, all should feel welcome to the meetings and it is the responsibility of the group to maintain an atmosphere of recovery. Each group is autonomous and will decide how to handle some specifics situations.
- 2) The Mental Health in Recovery IP. This IP originates from a motion at WSC 2016 and was placed on high priority ranking in the WSC literature survey. It is at an early stage of development and is intended for members in recovery who face mental health challenges. All are encouraged to offer their personal input either through their regional committees. Alternatively it can also be done on line at www.na.org/mhmi for an online input form or at worldboard@na.org for comments. A workshop was held on that IP and the participants at the conference did offer some good suggestions. The review period runs from February 1- May 15, 2019. This preliminary IP was a result of 792 pieces of input from 26 countries. After that a revised version of this IP will be inserted in the next Conference Agenda Report (CAR) for Fellowship-wide approval at the 2020 World Service Conference.

Greetings BASC and GSR's

The H&I subcommittee met on February 23, 2019 with only a few members in attendance and with the presence of Vice Chair (Interim) Larry A. I was not present for the subcommittee and the only report I received was from the H&I literature coordinator who help with the meeting agenda.

The H&I subcommittee are in need of acknowledgment of all H&I coordinators and panel members who have H&I commitments at the facilities we participate in. Coordinators are responsible of knowing their panel team and giving the subcommittee accurate contact information on the status reports.
