Free State Region April Meeting Report

Good morning, all,

I attended the hybrid On-Month Regional meeting on May 14, 2022. Five (5) areas were in attendance.

The following points were discussed in the meeting.

1) Service Center- Franck

- a) On January 1, 2023 the costs for all books and medallions at the world will go up 12 and 17% respectively. Prices of Key chains will not change.
- b) The World will publish a celebratory edition of the White Book with more stories to commemorate the 60th year anniversary since first printed.
- c) Spiritual Principles a Day book: approved. Will take approximately 6 months to production after approval. In the interim there is a free daily e-mail of that book for current day (same as the Just for Today daily e-mail).

2) Task force for NA Celebration at the Region

a) More details were revealed about the task force for celebration of the creation of NA in the Region. This will be a celebration of all old timers at the Region. Next month the task force will come to the On-month meeting with more details. We suggested to take into account the incoming BACNA convention dates of August 19-21 to avoid a scheduling overlap.

3) Free State- Wayne

The site for this year Convention has been selected. It will be at the Hyatt Regency, Downtown Baltimore on Light Street. The hotel offers more spaces for meetings. By having negotiate better terms on the deal, the Convention will be able to keep its goal

of Pre-Registration costs of \$10 for new comers <3 years and \$15 if >3 years. The only downsize will be the Parking costs at the hotel.

4) Policy Facilitator- Joe

The update for current policies is complete. Joe is also set to begin with the statutory audit of the treasurer books. Starting point will be August 2019, the date the current treasurer was voted in that position.

5) RD- Chris:

- a) Announced the NE Zone has decided not to participate in the exploratory committee for consolidation of the three Zones on the East Coast.
- b) US Zones Workgroup mtgs. Three parts Surveys package was presented:
 - a. Part 1: Narrative. Past USA do we need to move forward with it?
 - b. Part II Power print and You Tube presentations
 - c. Part 3: Are US Zones moving forward. The link for the survey monkey: https://www.surveymonkey.com/r/R2BXGCN
- c) South Eastern Zone Sunday July 10th will be hosting next US Zones meeting
- d) The WSC presented two recommendations regarding future of the WSC
 - a. A 3 years conference cycles trial for WSC from 2023 to 2029.
 - b. Delegate funding to be available to all participants upon request. Switch from Opt-out to Opt-in systems. Currently only the seated delegates received funding.
- e) Flow chart of functions of WSC is also attached to RD report at the Region.
- f) Monkey Surveys at the World on the revisions of IP: Loner Staying Clean in Isolation. The web addresses can be found in RD report
- g) Future of Motion L to be discussed: to retire current Hotels and Institutions Manual form NA Literature. Instead to update chapter VI or PR Manual to include H&I.
- h) CAR will be out in November. Al the previous Motions (I-V) were passed.
- i) Unfortunately, out of 600 Meetings in the Freestate Region, only 57 tally sheets received (should note that Susquehanna area did bundle his). A breakdown of the votes by each area is included in the RD report at the Region.

6) RDA- John

a) WS interim conference was on April 21-29. Discussions centered around the prize increase for Literature and medallions, publication of the new White Book (John signaled the book is already available for purchase at the world. Cost is \$15.00 + shipping). All six motions on the tally sheet of the CAR report passed.

- b) There were discussions on the future of WSC meetings. Topics were centered on time management, meeting format (in-person vs. virtual), attendance (in-person or virtual and/or who need to be physically present).
- c) Fellowship development was also included. The focus is on how to address gaps, targeting PR, training and mentoring.
- d) The consensus around the world seems to be lining toward three years cycles in between conferences. Before COVID it used to be two. If that happened, there will be some adjustments to be made at our Region around the required time to serve at those positions. Currently it is two years and was established to match the cycle of conventions.
- e) NAWS is updating the "The Loner Staying Clean in isolation" IP. A link for comments is available at www.na.org/survey.
- f) Just for Today e-book version is now available. The link for all e-books at the world can be found at www.na.org/elit.
- g) Events at World Service. The next World Service Conference will be held on April 30 to May 6, 2023, at Woodland Hills, California. The new CAR will be issued no later than November 30, 2022. A revised version of the *Guide to World Services in NA* has been posted to reflect changes on new conference cycles. It can be accessed at www.na.org/conference.
- h) Two webinars are on the work at the world
 - a. A webinar is scheduled for July 9, 2022 for new ideas on Fellowship Development.
 - b. The second will be for Unity Day, and will be on September 3, 2022. Freestate Region should also think about doing something at that time.
- i) Food for thoughts from RD and RDA
 - a. John and Chris discussed about the discrepancy which will be created if the WSC decides to go to a three years cycle. In order to align with new timeframe John will serve one year as RDA and then switch to RD for two years. The new RD and RDA after that will be expected to serve three years cycles.
 - b. Since all positions will be up in August, the Region can consider now posting for RD and RDA positions.
 - c. Meeting with the Zones for creation of Eastern Zone. Topics: do we want continue to meet with either SE or NE Zones? Consider joining a zone vs not joining?
 - d. The reasons NE decline to join the Work task is because they express their desire to focus on their geographical areas first.

7) Treasurer: Report is attached

8) Ad Hoc Committee for Insurance

Status quo. The RCM II from Delmarva was unable to make any contacts with members from New Jersey as promised.

- 1. Baltimore Pride Event. We paid \$125 of the \$250 one-day registration along with NEFA for the June 25th Baltimore Pride Event. FSRNA decided not to fund this activity, but will provide literature. The table will be on Charles Street. NEFA asked us to help with coverage in the afternoon, and have schedules for people who visit the booth. We sent a request to Time Printers for an estimate for printing 300 schedules. Time Printers gave the following estimates: \$275 for 300 copies, and \$400 for 500 copies. With these prices, and the frequently changing schedule information, we decided not to request schedules.
- 2. Baltimore Area Meeting Check Ups. The BASC Chair wants to create an ad hoc committee to visit Area meetings to encourage them to (1) register their meeting for inclusion in the schedule, and (2) to encourage them to send a representative and (3) donations to the Area. There was also discussion of resuming the bi-monthly workshops to re-familiarize groups with BASC and Area policies. This could be in conjunction with the two learning days referenced in the approved budget. We are looking for someone to take leadership of this project, and coordinate with other subcommittees.
- 3. CMDS* Fayette House's request for an H&I meeting is still pending with the H&I Subcommittee. We were informed that literature has been provided to the facility while discussions continue regarding whether the facility is eligible for H&I based on clients' access to NA meetings in the community.
