Greetings and welcome to all. Thank you for your love and commitment in your efforts to serve the BASC & the fellowship of Narcotics Anonymous.

Tradition Eleven (Abridged)

Our public relation policy is based on attraction rather than promotion. We need always maintain personal anonymity at the level of press, radio, and films.

...For us, attraction means simply sharing how NA works, and that it works. The power of our message is in our honesty. **Promotion** would be to make **guarantees** or **promises**, set an individual member up as a **"model recovering addict"**, or suggest that **NA is the best way to recover**. If we are not careful, our passion for NA could lead us to compromise the anonymity of ourselves or others, disrupt local services, and mislead others about NA. When we **trust** NA to be attractive to those seeking recovery, we can avoid the impulse to promote our program of recovery, and the challenges that result from doing so.

...Tradition eleven was written before the internet existed or before even television was in wide distribution. We communicate much differently today, and the media by which we communicate continues to evolve. So when we see **"at the level of press, radio, and films,"** we are obliged to ask: **"What is the equivalent today?"** We need to think about the spirit of the tradition-**the principle at its core**- as we consider how to apply it now. What does it mean to **maintain our personal anonymity** in a much less private world? We are called to practice this tradition with more vigilance than ever. **Guiding Principles -The spirit of our traditions pg198-199**

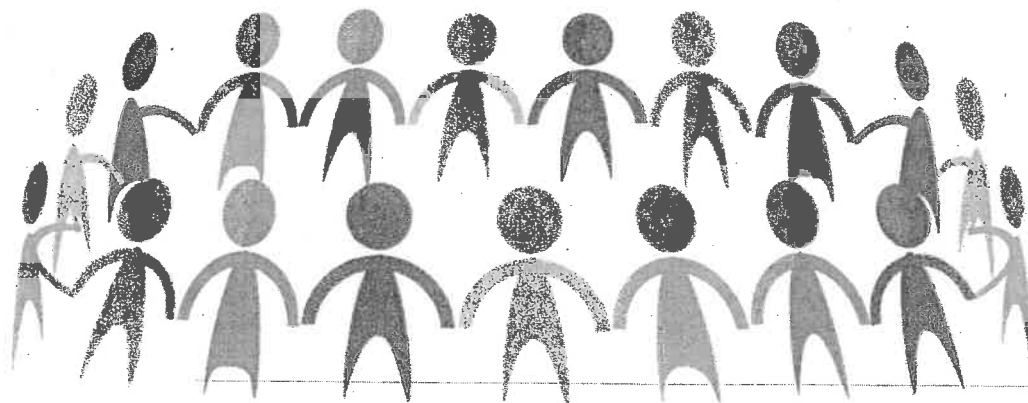
